Use and Condition of Vehicle:

Lessee agrees to use the vehicle in a careful and lawful manner and to comply with all applicable Australian laws and regulations. Lessee will not use the vehicle for any illegal purpose, racing, or reckless driving. The vehicle is leased in its current condition, and Lessee accepts it AS IS, subject to any disclosed faults or issues.

Maintenance and Repairs:

Lessee shall maintain the vehicle in good condition and perform routine maintenance as required. All repairs exceeding AUD 250 must have prior written consent from Lessor. Lessee shall notify Lessor immediately of any damage or mechanical issues.

Insurance:

Lessee must maintain comprehensive motor vehicle insurance covering damage, theft, third party liability, and public risk for the duration of the lease. Proof of insurance must be provided to Lessor prior to taking possession.

Registration and Roadworthiness:

Lessor warrants that the vehicle is registered and roadworthy at commencement. Lessee shall not alter or remove any registration plates or identification and shall notify Lessor of any defects affecting roadworthiness during the lease term.

Return of Vehicle:

Upon expiration or termination of this agreement, Lessee shall return the vehicle to Lessor in the same condition except for reasonable wear and tear. Any damage or loss beyond reasonable wear and tear shall be repaired or compensated by Lessee.

Default and Termination:

If Lessee fails to pay any amount when due or breaches any other term of this agreement, Lessor may provide written notice of default. If Lessee does not remedy the breach within 14 days, Lessor may terminate the lease and repossess the vehicle without prejudice to other rights or remedies.

Indemnity and Liability:

Lessee indemnifies Lessor against all claims, damages, losses, or liabilities arising from Lessee's use or possession of the vehicle, except to the extent caused by Lessor's negligence or breach of this agreement.

Governing Law and Jurisdiction:

This agreement is governed by and construed in accordance with the laws of Australia and the applicable state or territory where the vehicle is registered. The parties submit to the exclusive jurisdiction of the courts of that jurisdiction.

Entire Agreement:

This agreement constitutes the entire agreement between Lessor and Lessee and supersedes all prior negotiations, understandings, and agreements. Any amendments must be in writing signed by both parties.

Severability:

If any provision of this agreement is found to be invalid or unenforceable, the remaining provisions shall continue in full force and effect.
