Agreement Terms:

1. Purpose of Agreement

This Agreement sets out the terms and conditions for the provision of child support payments and responsibilities between the parties in accordance with the Child Support (Assessment) Act 1989 (Cth) and the Family Law Act 1975 (Cth).

2. Parental Responsibilities

Both parents agree to share parental responsibilities for the child(ren), including the care, welfare and development of the child(ren), consistent with the best interests of the child(ren).

3. Child Support Payments

Parent 1 Parent/Guardian shall pay Parent 2 Parent/Guardian child support as calculated by the Child Support Agency or as otherwise agreed by the parties herein. Payments shall be made in Australian Dollars (AUD) by direct deposit or other agreed payment methods.

4. Payment Frequency and Amount

Payments shall be made on a [weekly/fortnightly/monthly] basis in the amount of AUD _____. Any changes to payment amounts shall be notified in writing with reasonable notice.

5. Duration of Payments

Child support payments shall continue until the child(ren) reach the age of 18 years, or older if the child(ren) are still in secondary education, or as otherwise agreed in writing between the parties.

6. Medical and Educational Expenses

Both parents shall share the costs of reasonable medical, dental, educational, and extracurricular expenses of the child(ren) in proportion to their income, unless otherwise agreed.

7. Review and Variation

This Agreement may be reviewed or varied by mutual consent at any time. Either party may apply to the Child Support Agency or Family Court for a review or variation in accordance with applicable laws.

8. Dispute Resolution

In the event of any dispute arising from this Agreement, the parties agree to attempt to resolve the matter through mediation or family dispute resolution before pursuing court proceedings.

9. Confidentiality

The parties agree to keep all information relating to this Agreement confidential, except as required by law or to enforce the terms herein.

10. Legal Compliance

This Agreement complies with the legislation and regulations of the Commonwealth of Australia and the State or Territory in which it is executed. It is legally binding and enforceable.

11. Entire Agreement

This Agreement contains the entire understanding between the parties regarding child support and supersedes all prior agreements and understandings, whether written or oral.

12. Severability

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

13. Signatures

Both parties acknowledge that they have read, understood, and voluntarily accept the terms contained in this Agreement.
