Either party may terminate this Agreement with written notice if the other party breaches any material term and fails to remedy within 14 days of notice. Upon termination, the Contractor shall be entitled to payment for work performed to date.

**Dispute Resolution:**

In the event of a dispute arising out of or relating to this Agreement, parties shall attempt to resolve it amicably, and if unresolved, mediation or arbitration under Australian law may be pursued.

**Governing Law:**

This Agreement shall be governed by and construed in accordance with the laws of the State of New South Wales, Australia.

**Entire Agreement:**

This document, including any attached schedules, constitutes the entire agreement between the parties and supersedes all prior understandings, agreements, or representations.

**Amendments:**

Any amendments to this Agreement must be in writing and signed by both parties to be effective.

**Severability:**

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

**Counterparts and Execution:**

This Agreement may be executed in counterparts, each of which shall be deemed an original and all of which constitute one and the same instrument.
