Clause 1 – Agreement Scope

The Designer agrees to provide graphic design services as described in the Project Details section, and the Client agrees to pay for such services under the terms of this Agreement.

Clause 2 – Intellectual Property Rights

Upon full payment, the Designer assigns to the Client all intellectual property rights in the final deliverables. The Designer retains the right to use work in portfolios, marketing, and self-promotion unless expressly prohibited in writing.

Clause 3 – Revisions and Approvals

The Client is entitled to request revisions as specified in the Project Details. Additional revisions shall be billed separately. Final approval by the Client is required before delivery of final files.

Clause 4 – Confidentiality

Both parties agree to keep confidential any proprietary or sensitive information exchanged in connection with this Agreement, except as required by law or with prior written consent.

Clause 5 – Warranties and Representations

The Designer warrants that the services will be performed with reasonable skill and care. The Client warrants that any

materials provided do not infringe third-party rights.

Clause 6 – Limitation of Liability

Except for liability arising from gross negligence or willful misconduct, neither party shall be liable for indirect, incidental, or consequential damages arising from this Agreement.

Clause 7 – Termination

Either party may terminate this Agreement by written notice if the other party breaches any material term and fails to remedy it within a reasonable period. Upon termination, the Client shall pay for all work performed to date.

Clause 8 – Governing Law and Jurisdiction

This Agreement is governed by and construed in accordance with the laws of Australia. The parties submit to the exclusive jurisdiction of the courts of Australia for any disputes arising out of this Agreement.

Clause 9 – Entire Agreement

This Agreement constitutes the entire agreement between the parties and supersedes all prior negotiations and understandings. Any amendments must be in writing and signed by both parties.

Clause 10 – Notices

All notices under this Agreement must be in writing and delivered by hand, pre-paid post, or email to the addresses specified in this Agreement or as otherwise notified.
