Terms and Conditions:

1. Sale and Purchase

The Seller agrees to sell and the Buyer agrees to buy the vehicle described above on the terms set out in this Agreement.

2. Condition of Vehicle

The vehicle is sold 'as is' with all faults and without warranty, except as expressly stated in this Agreement. The Buyer has had the opportunity to inspect the vehicle and accepts its condition.

3. Title and Registration

The Seller warrants that they are the lawful owner of the vehicle and that the vehicle is free from all encumbrances. The Seller shall provide all necessary documents for transfer of ownership.

4. Risk and Liability

Risk in the vehicle passes to the Buyer upon payment and delivery. The Buyer is responsible for all insurance, registration, and maintenance after transfer.

5. Payment

The Buyer shall pay the sale price in full by the agreed payment method. Any deposit paid is non-refundable except as otherwise provided in this Agreement.

6. No Representations

No party has relied on any representation or warranty other than those expressly set out in this Agreement.

7. Cooling-off Period

There is no cooling-off period for this private sale under Queensland law.

8. Governing Law

This Agreement is governed by the laws of Queensland, Australia.

9. Entire Agreement

This Agreement constitutes the entire agreement between the parties and supersedes any prior negotiations or understandings.

10. Dispute Resolution

Any dispute arising out of or relating to this Agreement shall be resolved by negotiation, failing which by mediation, and if unresolved, by the courts of Queensland.

11. Signatures

This Agreement may be executed in counterparts and signed electronically or physically.
