Agreement Terms:

Clause 1 – Purpose of Agreement

This Agreement is made between the parents named above for the care, welfare, and support of the child(ren) listed. Both parties agree to comply with the terms set forth herein in the best interests of the child(ren).

Clause 2 – Parenting Arrangements

The parties agree to share parental responsibility and to cooperate in making decisions regarding the child's education, health, religion, and general welfare. Specific arrangements regarding time spent with each parent shall be detailed in the attached Schedule A.

Clause 3 – Child Support Payments

Parent 1 shall pay to Parent 2 the agreed amount of child support as outlined in the attached Schedule B. Payments shall be made by direct deposit or other agreed method on or before the agreed payment date each month. Payments continue until the child(ren) reach the age of majority or as otherwise agreed.

Clause 4 – Health Care and Insurance

Both parents shall share responsibility for the health care of the child(ren). Parent 1 shall maintain health insurance coverage for the child(ren) and provide proof of coverage upon request. Uncovered medical expenses shall be shared proportionally between the parties as detailed in Schedule C.

Clause 5 – Education Expenses

Expenses related to the child(ren)'s education, including tuition, uniforms, and extracurricular activities, shall be shared equally unless otherwise agreed. Both parties shall communicate promptly regarding school matters.

Clause 6 – Communication

Both parents agree to maintain open and respectful communication regarding the child(ren) and to notify each other

promptly of any significant events or changes affecting the child(ren).

Clause 7 – Dispute Resolution

In the event of any dispute arising out of or relating to this Agreement, the parties agree to attempt resolution through mediation before seeking further legal remedies.

Clause 8 – Variation and Review

This Agreement may be varied by mutual written consent of both parties. The parties agree to review the Agreement periodically or as circumstances change to ensure it remains in the best interests of the child(ren).

Clause 9 – Legal Compliance

This Agreement is intended to be legally binding and enforceable under the laws of Australia. The parties acknowledge they have had the opportunity to seek independent legal advice prior to signing.

Clause 10 – Confidentiality

The parties agree to keep the terms of this Agreement confidential except as required by law or agreed otherwise in writing.

Clause 11 – Termination

This Agreement shall remain in effect until the child(ren) reach the age of majority or as otherwise agreed or ordered by a court of competent jurisdiction.

Clause 12 – Signatures

The parties have read, understood, and voluntarily agree to the terms set forth in this Agreement.
