The Client agrees to pay the Service Provider the fees as detailed herein. All payments shall be made in Australian Dollars (AUD) according to the schedule set forth in this Agreement.

Clause 1 – Services Provided

The Service Provider shall provide the services described above and any additional services mutually agreed upon in writing by the parties.

Clause 2 – Standards of Service

The Service Provider warrants that all services will be carried out with reasonable care, skill, and in accordance with industry standards and applicable laws in Australia.

Clause 3 – Client Obligations

The Client agrees to provide all necessary cooperation, access, and information required by the Service Provider to perform the services effectively.

Clause 4 – Fees and Payment

Invoices shall be issued by the Service Provider according to the payment schedule. Payments are due within 14 days of invoice date unless otherwise agreed in writing.

Clause 5 – GST and Taxes

All fees are exclusive of Goods and Services Tax (GST) or other applicable taxes which shall be charged in addition where applicable under Australian law.

Clause 6 – Confidentiality

Each party agrees to keep confidential any proprietary or confidential information obtained during the course of this Agreement and not to disclose such information to any third party without prior written consent, except as required by law.

Clause 7 – Intellectual Property

Intellectual property created in connection with the services shall be owned by the Client, subject to full payment, unless otherwise agreed in writing.

Clause 8 – Liability and Indemnity

The Service Provider's liability for any claim arising under or in connection with this Agreement is limited to the value of fees paid by the Client. The Client indemnifies the Service Provider against any claims arising from Client's breach or negligent acts.

Clause 9 – Termination

Either party may terminate this Agreement with 14 days written notice. Upon termination, Client shall pay for all services rendered up to the termination date.

Clause 10 – Force Majeure

Neither party shall be liable for failure or delay in performance due to causes beyond their reasonable control including but not limited to natural disasters, governmental actions, or other force majeure events.

Clause 11 – Dispute Resolution

The parties agree to attempt to resolve disputes amicably through negotiation. If unresolved, disputes shall be subject to mediation and if necessary, arbitration in accordance with the laws of Australia.

Clause 12 – Governing Law

This Agreement shall be governed by and construed in accordance with the laws of Australia. The parties submit to the exclusive jurisdiction of the courts of Australia.

Clause 13 – Entire Agreement

This Agreement constitutes the entire understanding between the parties and supersedes all prior negotiations and agreements, written or oral, relating to its subject matter.

Clause 14 – Amendments

No amendment or variation of this Agreement shall be effective unless in writing and signed by both parties.

Clause 15 – Notices

All notices must be in writing and delivered personally, by registered mail, or by email to the addresses specified in this Agreement or as notified in writing by either party.
