Clause 1 – Agreement to Sell and Purchase

The Seller agrees to sell and the Buyer agrees to buy the Vehicle described above on the terms contained in this Agreement. The Seller warrants that they are the lawful owner of the Vehicle and have full power to sell it.

Clause 2 – Vehicle Condition; 'As Is' Sale

The Vehicle is sold 'as is' and 'where is' without any warranties except as expressly stated in this Agreement. The Buyer acknowledges having inspected the Vehicle or having had the opportunity to do so and accepts its condition.

Clause 3 – Title and Registration

The Seller will provide the Buyer with proof of ownership and any necessary documents to enable transfer of registration and title according to Australian law.

Clause 4 – Purchase Price and Payment

The Purchase Price is the amount specified above. Payment shall be made in full by the Buyer to the Seller by the agreed method before or at the time of delivery.

Clause 5 – Delivery

Delivery of the Vehicle shall occur at the agreed location. Risk in the Vehicle passes to the Buyer upon delivery.

Clause 6 – Warranties and Disclosures

The Seller represents that the Vehicle is free from encumbrances except those disclosed, and to the best of their knowledge, there are no outstanding fines or charges associated with the Vehicle.

Clause 7 – Odometer Disclosure

The Seller confirms that the odometer reading is accurate to the best of their knowledge and that it has not been altered or disconnected.

Clause 8 – No Other Representations

No other representations or warranties are made by the Seller except those expressly set forth in this Agreement.

Clause 9 – Governing Law

This Agreement is governed by and construed in accordance with the laws of the Commonwealth of Australia and the relevant state or territory laws.

Clause 10 – Entire Agreement

This Agreement constitutes the entire agreement between the parties and supersedes all prior negotiations and understandings.

Clause 11 – Severability

If any provision of this Agreement is held to be invalid or unenforceable, the remaining provisions shall continue in full force and effect.

Clause 12 – Dispute Resolution

In the event of any dispute arising from this Agreement, the parties shall attempt to resolve the matter by mediation before resorting to litigation.

Clause 13 – Signatures

This Agreement may be signed in counterparts and by electronic means, each of which is deemed an original.

Clause 14 – Privacy

The parties consent to the processing of personal information for the purposes of this Agreement in accordance with applicable privacy laws.

Clause 15 – Notices

Notices under this Agreement shall be in writing and delivered by hand, post, or electronic means to the addresses set out herein.

Clause 16 – No Assignment

Neither party may assign their rights or obligations under this Agreement without the prior written consent of the other party.

Clause 17 – Costs

Each party shall bear their own costs in relation to the preparation, negotiation, and execution of this Agreement.

Clause 18 – Amendments

Any amendments to this Agreement must be in writing and signed by both parties.

Clause 19 – Consumer Guarantees Act

Where applicable, certain consumer guarantees under Australian Consumer Law may apply; however, the Vehicle is sold as a private sale and no additional warranties are implied beyond those stated.

Clause 20 – Acknowledgment

Each party acknowledges having read and understood this Agreement and agrees to be bound by its terms.
